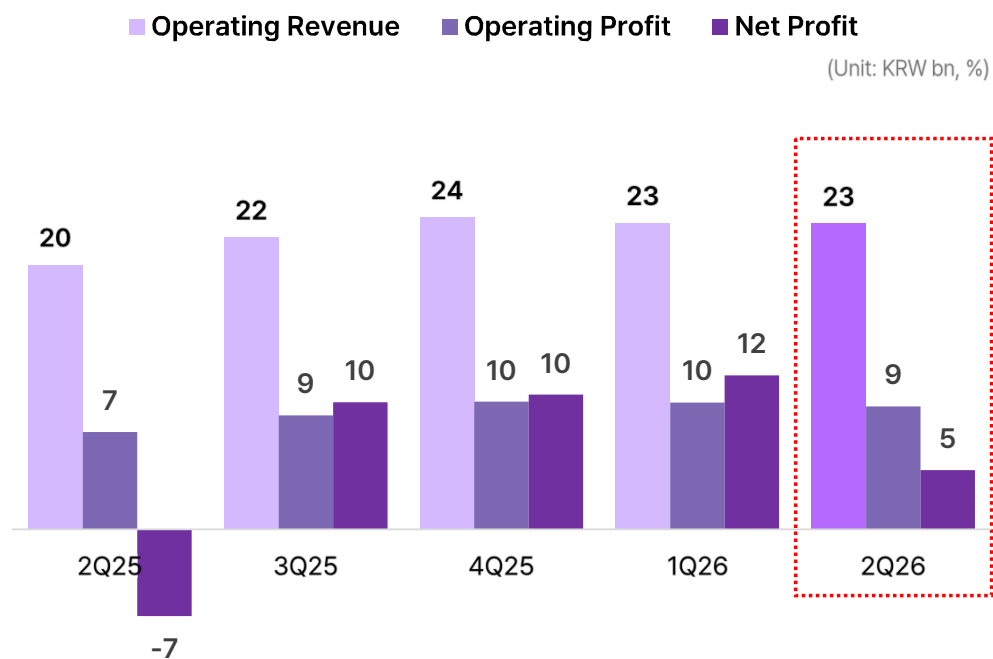

2Q26 Review

2Q26

Operating Revenue: W 23.4 bn (-0.2% QoQ, +15.7% YoY)

Operating Profit: W 9.4 bn (-3.0% QoQ, +26.4% YoY)

Net Profit: W 4.5 bn (-61.5% QoQ, turned to profit YoY)

Subscription dropped slightly by 2% QoQ, while favorable FX effects largely offset the revenue impact

- Subscription: 2.01 million 1Q26 -> **1.97 million 2Q26**
- Recognition of TME royalty revenue beyond the March accrual was deferred to 2Q26, while QQ Music Bubble continues to deliver steady subscriber growth
- JOOX royalties were not recognized in 1H26 and are expected to be reflected in 3Q26

- Recognition of large-scale impairment on artist MG advance payment assets

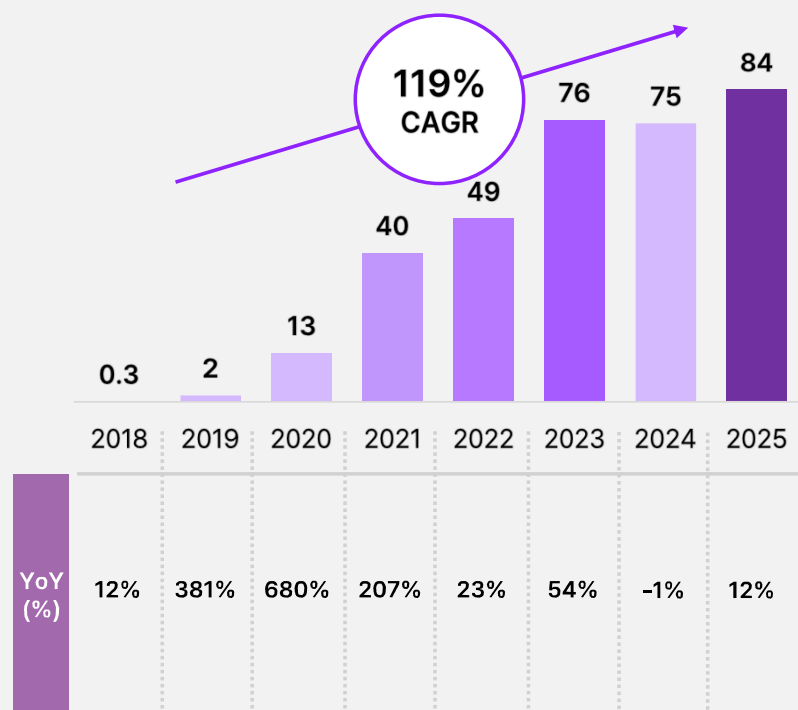

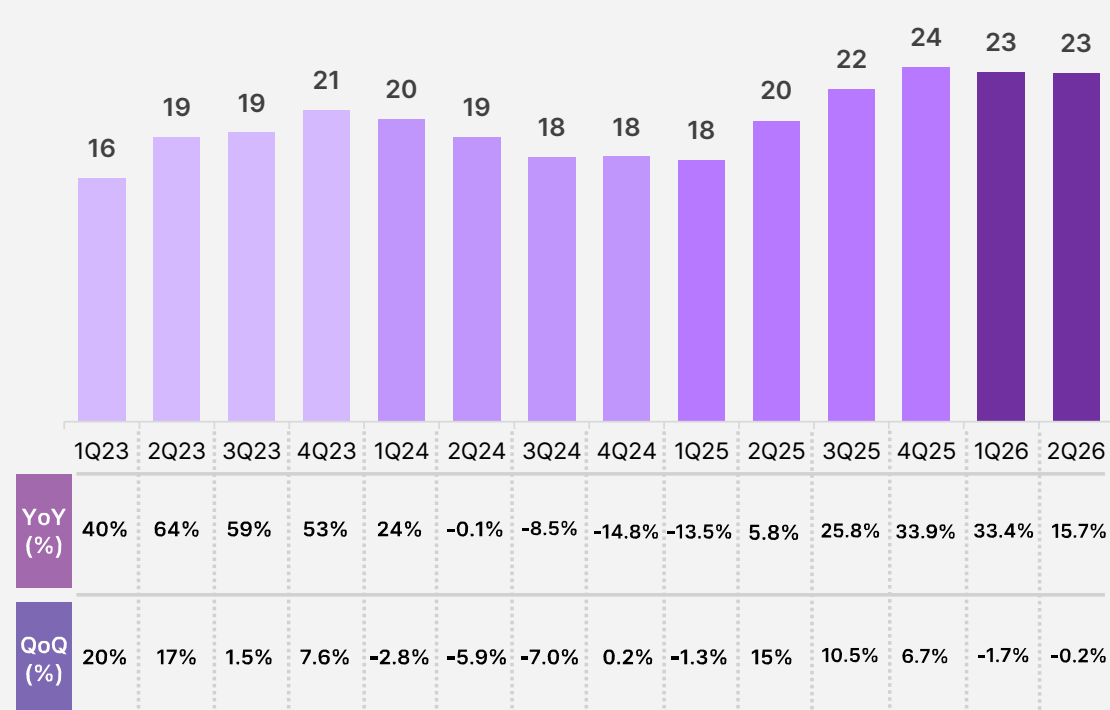
Annual Operating Revenue

(Unit: KRW bn, %)



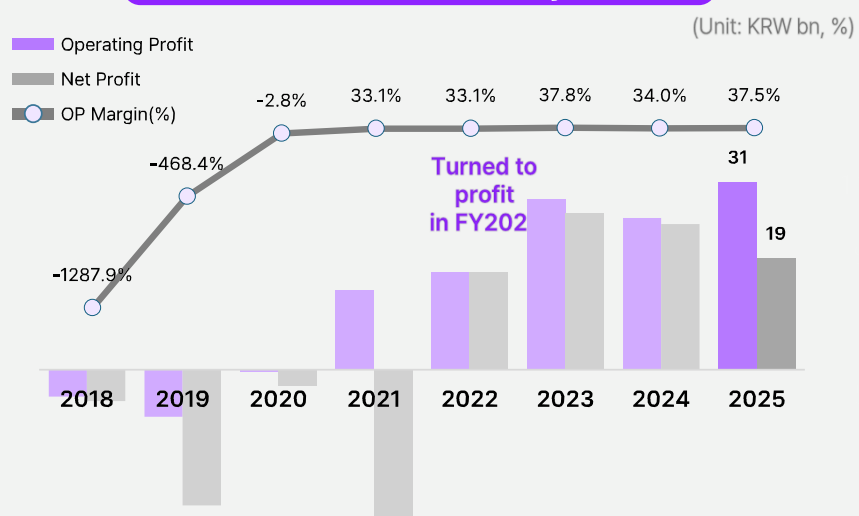
Quarterly Operating Revenue

Annual Profitability



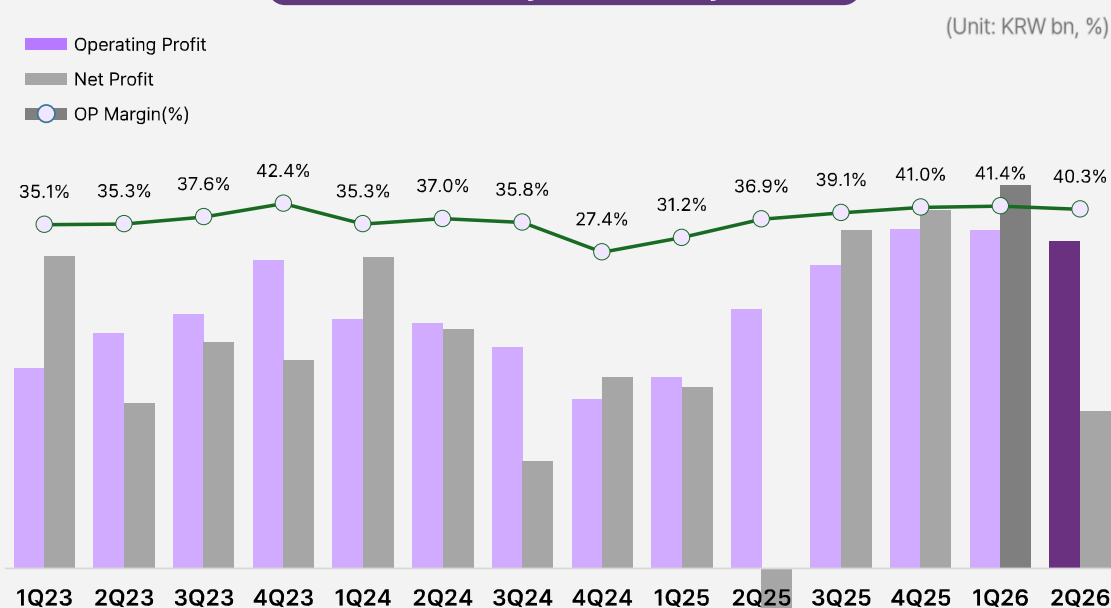

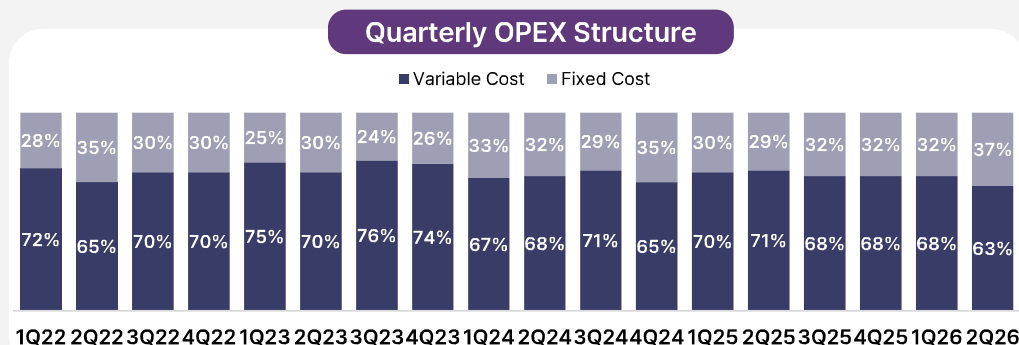
